Bidders shall submit their bids not later than: **13/12/2017 until 10:00h** at Clerks office of the Contracting Authority: Joint stock company "Elektromreža Srbije", Kneza Miloša 11, Belgrade. Bids shall be submitted in a sealed envelope or box, so when they are opened it may be ascertained with certainty that it is their first opening, indicating:

The correct name and address of the Bidder shall be put on the back of the envelope or box. The bid can be submitted by mail or in person, not later than the final date for the submission, until 10:00 hours, local time.

Untimely bids will not be taken into consideration and shall be returned unopened to the bidders. Timeliness will be judged solely by the date and time of arrival to the clerks office of the Contracting Authority, and not by the day and hour of their hand-over in the post office.

Place, Date/Time and Manner of Opening of Bids:

Public opening of all timely received bids shall be done on **13/12/2017 at 10:30h** in the premises of the Contracting Authority, at EMS JSC address being Kneza Miloša 11 Street, 11000 Belgrade, in the presence of the Public Procurement Committee members appointed for the subject-matter public procurement.

Conditions under which bidders' representatives may participate in the opening procedure:

Opening of bids will be publicly made and each interested party may be present thereto. Only the authorized representatives of Bidders may actively participate in the opening of bids. Before the start of the public opening, the Bidders' representatives who want to attend the bid opening shall submit to the Contracting Authority's representatives special written authorizations, which are certified by a seal and signature, for the participation in the public opening of bids.

Time limit for making Decision:

Decision on awarding the contract for the public procurement procedure in matter will be made within 25 days as from the public opening of bids.
