## Way of work on borders

- ▶ border working in sessions: RO.
- ▶ borders on which the continuous ID process is applied:  
MK, ME, BA, HR, HU and BG.

## Intraday Process 2021

### Border working in sessions – RO border

- ▶ 6 session, 4 block hours.
- ▶ TEL acts as intraday Allocation Office (DAMAS).

## Intraday Process 2021

**Borders on which the continuous ID process is applied are:**

MK, ME, BA, HR, HU and BG

- ▶ Balance Responsible Parties will be able to allocate ID capacity from 18:00 CET in D-1 for D, but **no later than 60 minutes** before first hour with change.
- ▶ Balance Responsible Parties will be able to submit their Balance Responsible Schedules from 18:00 CET in D-1 for D, **but no later than 45 minutes** before first hour with change.

## Intraday Process 2021

**Borders on which the continuous ID process is applied are:**

MK, ME, BA, HR, HU and BG

- ▶ Cutoff gate is **30 min** before first hour with change.
- ▶ Confirmation of BRP no later than **15 min** before first hour with change (CNF).

## Intraday Process 2021

- ▶ Balance Responsible Parties will be able to submit their internal transaction, Consumption Responsible Schedules and Production Responsible Schedule **from 18:00 CET in D-1 for D, but no later than 45 minutes** before first hour with change.
- ▶ Checking of the internal mismatch and imbalance (Matching cycle) will be performed every 15 minutes (00, 15, 30 and 45 min) when the system send notification to the traders (ACK, CNF or ANO).

## Continuous ID process on BG-RS border

- ▶ EMS acts as intraday Allocation Office (Transmission Capacity Allocator - TCA).
- ▶ Balance Responsible Parties will be able to allocate ID capacity from 18:00 CET in D-1 for D, but **no later than 60 minutes** before first hour with change.
- ▶ Balance Responsible Parties will be able to submit their Balance Responsible Schedules from 18:00 CET in D-1 for D, **but no later than 45 minutes** before first hour with change.

## Matching process on BG-RS border

- ▶ Matching cycle every hour starting from 19:00 CET in D-1 for D.
- ▶ Nominations will be matched in the first possible matching cycle.
- ▶ In case of mismatch cut-off will be performed **30 minutes** before first hour with change.
- ▶ In case of mismatch lower value principle will be apply.
- ▶ Mismatched nomination will be possible to modify no later then 45 minutes before first hour with change.
- ▶ Confirmed nomination will not be possible to modify even if the respective hour will not be closed yet.



## Intraday Process 2021

### Continuous ID process on ME-RS border

- ▶ Joint Auctions Montenegro - Serbia (100%).
- ▶ CGES acts as intraday Allocation Office (Transmission Capacity Allocator - TCA).
- ▶ Allocated capacity must be nominated no later than 60 minutes after allocation.
- ▶ After 60 minutes the capacity value will be set to zero.
