









Return of capacity on BARS and MERS borders

- Payment for Yearly auctions is done on different day from payment for Monthly auctions
- The Holder of the Allocated Capacity at yearly Auction may return to the Auction Office part or the entire amount of the Allocated Capacity for reallocation at the next monthly Auction
- Announcement of the preliminary ATC will be done separately from final ATC publishing. Final ATC publishing will be done 2 days before the monthly auctions and after the process of Return of capacity
- Return shall be done from 8:00 to 11:00 on the day for return of capacity stated in the calendar
- Final ATC announcement: 14:00 2 days before the monthly auctions
- Return will be done via the Transfer / Return menu so that the registered participant who wants to return the capacity will do so by returning the capacity to EMS on the date specified for Return according to the calendar
- Calendar of monthly and yearly auctions is published on the EMS website




UIOSI on BARS and MERS borders

- If the registered participant does not nominate yearly and monthly capacity, that capacity will be reallocated at the daily auction and will be subject to the UIOSI principle
- For holders of yearly and monthly Allocated Capacity, the reimburement for non-nominated yearly and monthly Allocated Capacity is set as the difference between Allocated Capacity at yearly and monthly Auctions and the value of nomination multiplied by the price achieved at daily auctions in the corresponding hour.
- The price at daily auctions is defined by the Daily Auction Rules between NOSBiH/CGES and EMS.




Yearly Auctions for 2022
